Welcome to Academic Year 2023. This circular is to inform parents on Aspire Institute's policies. Please take some time to read through the entire circular.

A: Electronic Fee Invoice

A fee invoice will be given to you via email on the 1st week of each month. This is to help remind you of the upcoming fee payment.

Kindly inform our Accounts Department at **9477 9230** of any changes in your email address. For GIRO payments, please ensure there is sufficient funds in your bank accounts to ensure a successful deduction. If you are paying the fees by bank transfer, please observe the following for ease of recording and retrieving at our end.

B: Fee Payment Date

Fee is due on the **21**st of each month, prior to the start of the month. For example, April fee is due on 21st of March, May fee is due on 21st of April and so forth. If you have opted for GIRO payment, please ensure that there are sufficient funds to be deducted on 21st of each month.

D: Fee Increment

There will be an increase in our monthly fee due to the rising cost of expenses with effect from **March 2023.** Below are the revised fees that will be applicable from **March 2023.**

Description	Amount
Daily Program	\$385.00 (GST Included)
Bi-Weekly Program	\$285.00 (GST Included)

We have revised the sibling discount rate to \$30 Off for the second child onwards. This is only applicable to those who are enrolled in our **Daily** program.

In the event where your child is unable to attend the program due to any reason during the school holidays, you are still required to pay the full month fee for that period. No prorating of fees will be allowed.

E: Additional Administrative Fee for Late Payment

An additional administrative fee for late payment will be levied at \$10/weekly. We seek your kind understanding and cooperation in ensuring that all fees are paid promptly for smooth operation.

F: GST-Registered Company

With effect from **2**nd **December 2022**, ASPIREINSTITUTE.COM PTE LTD is required by law to be GST-registered. Henceforth, all fees will be subjected to the prevailing GST rate.

For January 2023 Fee (No action is needed as fee has been paid during registration)

For February 2023 Fee (To be paid on 21st January 2023)

Parents will have to pay an additional 8% GST on top of the monthly fee.
